All staff are inducted into our daily safeguarding procedures and have received child protection training. Our aim is to:

- ◆ prevent children being abused
- ◆ identify signs and symptoms
- ◆ record incidents, issues and concerns

We are aware that safeguarding is not just about protecting children from deliberate harm. It includes:

- ◆ pupils' health and safety
- ◆ all aspects of behaviour such as bullying, racism and discrimination
- ◆ meeting the needs of pupils with medical needs
- ◆ providing First Aid from trained staff
- ◆ educational visits
- ◆ internet Safety
- ◆ school security
