I understand the terms and conditions of the following fees:

## **Fees**

From the beginning of the term following a child's third birthday your child can access 10 funded hours per week. The Additional hour (11am-12pm) for the 3+ children will be charged at:

£4.50 per hour

All 3+ who choose to use our Wrap around Service will be charged £18.00 in total. This covers morning and afternoon sessions.

Two-Year-olds accessing the morning sessions only will be charged £13.50 (9am-12)

Two-year-olds accessing the afternoon session only will be charged £9.00 (1pm-3pm)

Two-year-olds who attend our wrap around service (9am-3pm)) will be charged at £27.00

### Flying Start

From the beginning of the term following a child's second birthday your child can access 12.5 funded hours per week. The Additional half an hour (11:30am-12pm) for the 2-year-old children will be charged at: £2.25 per hour

Fees due for your child's sessions are to be paid in advance on a weekly basis. They are non-refundable. Unless otherwise arranged with the Play Leader/Manager. It is the responsibility of the parent/guardian to maintain payments inline with the settings policies.

3+ session fees are to be paid through ParentPay.

By agreement of commencement the setting have the right to complete assessments to monitor your child's development.

## <u>Assessment arrangements for Recording and Observing at funded non-maintained nursery settings</u>

The '<u>Curriculum and Assessment (Wales) Act 2021'</u> (legislation.gov.uk) sets out the requirements relating to the design and implementation of curriculum and assessment arrangements.

As practitioners we have a duty to make provision about assessment arrangements. (a)The progress made by pupils and children (b)the next steps in their progression, and(c)the teaching and learning needed to make that progress.

In doing so, the following legislation 'Supporting learner progression assessment guidance' provides practitioners with the right to identify the progress being made by an individual learner, and **record** this, where appropriate, to understand the learner's journey over different periods of time and in a variety of ways. This includes developing an understanding of how a learner has learned, as well as what they have learned and are able to demonstrate.

Assessment arrangements support teaching and learning only and the 'framework for evaluation, improvement and accountability' states that assessment should not be undertaken for accountability purposes. The purpose should be to better support children's learning and development and this is what we stive to do, at Cewri Bach Playgroup.

## **Absence**

There will be no Fee for absence. Session fees are non-refundable.

### Snack

The playgroup supports Powys Healthy Eating and complies with the National Minimum Standards in accordance with Welsh Government guidance 'Food and Nutrition for Childcare settings' We encourage healthy eating and drinking and promote healthy lifestyles through physical activities, safety and personal wellbeing.

Milk and Water is provided at the setting for **ALL** children. Already filled drink bottles can be brought in if you wish, although we encourage water only. 3+ and non-eligible flying start 2-year-old children will need to be provided with a piece of fruit/healthy snack for morning and afternoon break.

## Our Flying Start / 2-year-old setting

We provide a "tooth friendly" snack such as toast, fruit, crackers, dried fruits, cereal and yoghurt.

No snack contribution is required for <u>FLYING START</u> children. Snack and refreshments will be funded through the Welsh Government.

### **Notice**

The provision will require one month notice of the child leaving the provision.

- I agree to collect/make arrangements for my child to be collected from the provision immediately if I am informed that s/he is unwell
